DIRECTIONS TO WAREHOUSE TO VIEW THE INVENTORY

FROM THE NEW ORLEANS INTERNATIONAL AIRPORT: (Approx. 73 miles total trip.) From the New Orleans airport area, follow the signs to Interstate 10 West. Drive approx. 16 miles west on I-10 to the exit for Interstate 55 North. Proceed on I-55 north for 29 miles to Exit #29B for Interstate 12 West. Proceed on I-12 West for 22.5 miles to Exit #15 for LA 447/Walker. Turn right (north) onto LA 447 and proceed 1.4 miles to the traffic light at U.S. Highway 190. Turn right (east) onto U.S. Hwy. 190 and proceed 1.6 miles to LA 449/North Corbin Road. This will be on your left. Turn left (north) onto LA 449 and proceed 1.6 miles to the McDonald Fitting and Flange facility on your left. Watch for auction signs.

FROM THE BATON ROUGE REGIONAL AIRPORT: (Approx. 21 miles total trip.) Follow the signs out of the airport area to Interstate 110 South. Proceed on I-110 South to the intersection of Interstate 10. Proceed on I-10 East (towards New Orleans) and, after you pass the Marriott Hotel sale site near the College Dr. exit, you will come to the I-10/I-12 split. Take the left fork onto I-12 (towards Hammond) and proceed to Exit #15 for LA 447/Walker. Turn left (north) onto LA 447 and proceed 1.4 miles to the traffic light at U.S. Highway 190. Turn right (east) onto U.S. Hwy. 190 and proceed 1.6 miles to LA 449/North Corbin Road. This will be your left. Turn left (north) onto LA 449/North Corbin Road and proceed 1.6 miles to the McDonald Fitting and Flange facility on your left. Watch for auction signs.

DIRECTIONS FROM WAREHOUSE TO SALE SITE

FROM THE McDONALD WAREHOUSE TO THE MARRIOTT COLOR SLIDE AUCTION SITE: Leaving the warehouse, turn right onto LA 449/North Corbin Road and proceed south 1.6 miles back to U.S. Hwy. 190. Turn right onto Hwy. 190 and proceed west back to the traffic light at LA 447. Turn left and proceed south back to I-12. Get onto I-12 heading west toward Baton Rouge and proceed approx. 13 miles to Exit #15 for College Drive. (I-12 and I-10 will have merged by this point. Also, you will see the Marriott ahead as it is the tallest building around.) Exit and turn right (north) onto College. Proceed to the next traffic light and turn right (east) onto Corporate Blvd. Proceed a short distance and turn right onto Trust Drive. Take the next left onto Hilton Ave. and the Marriott will be ahead on your right.
